**रतुल पुरी की अग्रिम जमानत याचिका खारिज**

अदालत ने वीवीआइपी अग्रस्ता वेस्टलैंड हेलिकॉप्टर घोटाले से जुड़े धनशोधन मामले में मध्य प्रदेश के मुख्यमंत्री कमलनाथ के भांजे रतुल पुरी की अग्रिम जमानत याचिका खारिज कर दी। विशेष न्यायाधीश अचिंत कुमार ने दलीलों सुनने के बाद यह फैसला किया।

जज ने पुरी को राहत देने से इनकार कर दिया और फैसले में कहा कि पुरी के खिलाफ जो भी मामला है, जिस मोड़ पर है, उनको अग्रिम जमानत की अर्जी स्वीकार नहीं की जा सकती। हालांकि इससे पहले सुनवाई के दौरान रतुल के वकील विजय अग्रवाल ने अदालत को बताया कि उनके मुक्किल जब डंडी चाहें तब उनके सम्पर्क पेश होने को तैयार हैं। लिहाजा उनसे हिरासत में पूछताछ की कोई आवश्यकता नहीं है।

बता दें कि पुरी ने अपनी अग्रिम जमानत अर्जी में दावा किया कि वे जांच में सहयोग कर रहे हैं। लेकिन एजेंसी उन्हें राजनीतिक बदले की कार्रवाई के चलते गिरफ्तार करना चाहती है। हालांकि प्रवर्तन निदेशालय ने इस आरोप से इनकार किया था। इस बीच, पुरी ने दिल्ली हाई कोर्ट से अपनी याचिका वापस भी ले ली जिसमें उन्होंने निचली अदालत को यह निर्देश देने की मांग की थी कि वह उनके लंबित अन्य आवेदनों पर सुनवाई किए बगैर, अग्रिम जमानत पर आदेश पारित नहीं करे।

उन्होंने बताया कि इन योजनाओं का लाभ जम्मू, कश्मीर और लद्दाख के छात्रों को मिलेगा। यहां उच्च शिक्षा के लिए मूलभूत ढांचे की कमी है। आयोग बुनियादी ढांचे के निर्माण के लिए काम करेगा।

केंद्रीय माध्यमिक शिक्षा बोर्ड (सीबीएसई) अगले साल 15 फरवरी से ही कक्षा 10 और 12 की बोर्ड परीक्षाएं शुरू करेगा। 2019 की परीक्षाएं भी 15 फरवरी से ही शुरू हुई थीं और परीक्षाओं के इस कार्यक्रम को 2020 में आयोजित होने वाली परीक्षाओं में भी उपयोग किया जाएगा।

सीबीएसई के एक वरिष्ठ अधिकारी के मुताबिक 2020 में होने वाली परीक्षाओं के कार्यक्रम पर अभी काम शुरू नहीं हुआ है। लेकिन यह तय है कि परीक्षाएं 2019 की भांति फरवरी के 15वें कार्यदिवस से शुरू हो जाएंगी। उन्होंने बताया कि जल्द परीक्षाएं शुरू करने से मूल्यांकन का कार्य तसल्ली से होता है जिससे उसमें गलती की गुंजाइश खत्म हो जाती है। इसके अलावा पुनर्मूल्यांकन का परिणाम भी हम जल्द देने में सक्षम होते हैं। इससे विद्यार्थियों में दाखिला लेने वाले विद्यार्थियों का साल बर्बाद होने से बच जाता है।

अधिकारी ने बताया कि यह अभी तय नहीं है कि 2019 की परीक्षाओं की तरह अगले साल पहले वोकेशनल विषयों की परीक्षाएं होंगी या प्रमुख विषयों की।
